Draka Angled Shutters are available in the Euromod 25mm x 50mm and 6C (LJ6C) 25mm x 38mm sizes. Blanking plates are available in half and quarter size for Euromod 25mm x 50mm size to configure single or triple outlets.

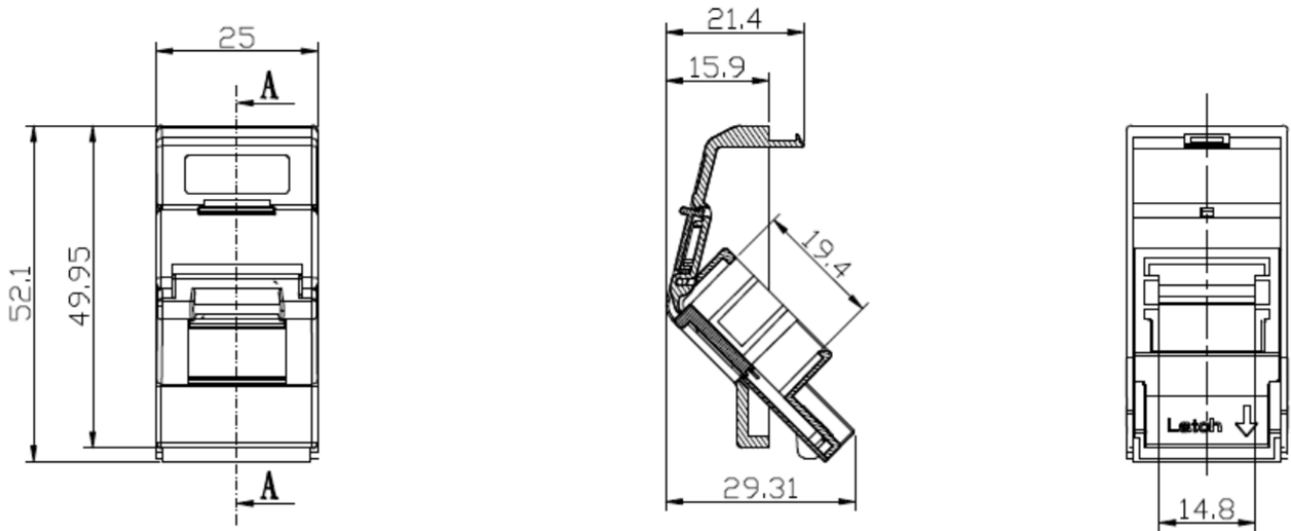
